Re: Dr. Hassan Diab

The International Civil Liberties Monitoring Group (ICLMG) is a broad coalition of 40 Canadian civil society organizations dedicated to the defence of civil liberties and human rights (see appendix).

ICLMG has been monitoring the case of Canadian citizen and university professor, Dr. Hassan Diab, and is gravely troubled by the nature of the information being presented in Canadian courts in this extradition case.

France seeks the extradition of Ottawa professor Hassan Diab, on charges relating to the bombing of a French synagogue in 1980. Dr. Diab has no criminal record. He has taught at both the University of Ottawa and Carleton University until his unjust termination by Carleton University soon after the French government's allegations became public. ICLMG is extremely concerned by the use of secret "intelligence" information from unidentified sources – especially information that may have been obtained from torture – as is happening in this case, to try to justify France's request.

In any extradition case in Canada, the court must ensure there is sufficient evidence to support the extradition request, and, importantly, that the evidence is *reliable*. This does not appear to have been the case in Dr. Diab's extradition hearing, where neither the application judge nor the Crown counsel acting on France's behalf knows the source of "evidence" being used, or where and how France obtained it. Even more troubling is the possibility that some of this information may have derived from torture.

The reliability of unsourced evidence cannot be adequately tested or challenged. As such, it should not be admitted into nor relied upon in a Canadian extradition hearing. Furthermore, Canadian officials and Canadian courts must ensure that any information that may be the product of torture is excluded from extradition hearings and all court proceedings. As an additional crucial safeguard, extradition requests should be denied where there is a serious risk that evidence derived from torture will be presented and admitted as evidence in the trial.

ICLMG calls on the Canadian government and the courts to stop the use of unsourced information in Dr. Diab's case and others like his. To do otherwise could have far-reaching implications, undermining the test for extradition and resulting in unfair process and injustices for others suspected of crimes by foreign states.

We thus ask you, Minister, to exercise the power granted to you under extradition law to immediately halt extradition proceedings against Dr. Diab, unless and until reliable evidence is presented in support of the French government's request, and to act on your legal obligation to refuse to make "unjust and oppressive" extradition orders.
