Dear Minister Wilson-Raybould,

Re: The case of Dr. Hassan Diab

First we would like to congratulate you on your appointment as Minister of Justice and offer our best wishes for success in this challenging portfolio. We look forward to working closely with your department to improve the means and effectiveness of Canada's commitment to justice for all of its residents.

The International Civil Liberties Monitoring Group (ICLMG) is a broad coalition of over 40 Canadian civil society organizations dedicated to the defence of civil liberties and human rights (see appendix).

ICLMG has been monitoring the case of Canadian citizen and university professor, Dr. Hassan Diab, since his arrest in 2008 for an alleged involvement in a bombing near a synagogue on rue Copernic in Paris, France in 1980.

During his court case and until his subsequent extradition to France, ICLMG raised grave concerns about the nature of the information being presented in Canadian courts.

We constantly repeated that in any extradition case in Canada, the court must ensure there is sufficient evidence to support the extradition request, and, importantly, that the evidence is *reliable*. This did not appear to have been the case in Dr. Diab's extradition hearing. Even more troubling is the possibility that some of this information may have derived from torture. The reliability of "unsourced" evidence cannot be adequately tested or challenged.

Furthermore, we reminded Canadian officials and Canadian courts to ensure that any information that may be the product of torture should be excluded from extradition hearings and all court proceedings. As an additional safeguard, extradition requests should be denied where there is a serious risk that evidence derived from torture will be presented and admitted as evidence in the trial.

Since his extradition to France in 2014, Dr. Hassan Diab has been languishing in a prison near Paris, where he may remain there for two or more years while an investigating magistrate decides whether to bring his case to trial.

We therefore ask you, the Honourable Minister of Justice, to raise the case of Dr. Hassan Diab with your French counterpart and make sure that French authorities do not use against Dr. Diab any "unsourced" intelligence and/or the flawed handwriting reports that were withdrawn from the Canadian proceedings. Dr. Hassan Diab should not have been extradited to France. He should be brought back to Canada.
